LCC 16/149 PRELIMINARY MATTERS

a. Apologies

Councillor J. Williams.

Chair advised the meeting that Councillor J. Williams wishes to tender his resignation as community councillor due to work commitments, the clerk agreed to contact him to obtain this instruction in writing before the replacement vacancy is formally advertised. Members wished to thank Councillor J. Williams for his contribution to the community council over the last two and a half years.

Minutes of the Meeting of the Council held on Tuesday 8th March 2016 (Min. No's 135 – 147).

The Minutes were approved as a correct record.

c. Matters arising from the above mentioned Minutes

[Min No 136(i)] Clerk has placed an order for 6 No 150 x 200mm self-adhesive dog waste bin stickers. These will we placed on bins around the village as soon as they arrive. It was suggested at the meeting that dog owners in the village receive a notice advising them that dog fouling will not be tolerated, and that dogs on the Margaret Bowen playing field be kept on a lead at all times.

[Min No 142]. Chair has provided the clerk with signage dimensions for planter provision as requested. Clerk confirmed that the wild flower seed pack has arrived, and was handed over to Councillor Mrs J. Roberts.

It was agreed not to purchase planters for installation below the Llanarthne village signage, but to create a planting area in lieu, Councillor P. Edwards and Councillor Mrs J. Roberts to oversee this work, and purchase planting compost/shrubs as required.

d. Declarations of Personal Interest

Councillor H. Bryer and Councillor Mrs M. Tobias Quick declared a personal but non-prejudicial interest on Min No 153(c).

LCC 16/150 AREA MATTERS

- 1. Clerk has received a request from Mr & Mrs Daymond to have a bin installed at the former picnic site near Ffinnant Bridge. Clerk will write to them and thank them for recently collecting and bagging the rubbish left by users there.
- 2. Clerk has received a report of a verge road defect between Saron Chapel and Pistyll Dewi, Llanarthne on the B4300 from the Highway Authority.
- 3. Lamp near Saron Chapel is flickering and needs attention reported 14.03.16
- 4. The cycle route (Route 47) has a number of potholes, clerk to establish what the current highway maintenance policy is for this cycle route.
- 5. Despite submitting concerns (November 2015) about the Biodigester Septic Tank installed near Hafan-deg, Llanarthne, members request a response as to why this tank is being emptied so frequently.
- 6. Overhanging branches leaning onto the highway and overhead lines remain a problem especially to power and telephone distribution lines from Pont-Felingat to Dolau-Gwynon and requires immediate attention.
- 7. Garden waste is being tipped over the Hafan-deg boundary fence onto the common area of land.
- 8. Overhanging trees and branches leaning onto the highway and overhead lines on the B4300, Llanarthne to Golden Grove.
- 9. Reported again that the highway lighting on the slip road at Porthyrhyd roundabout is sometimes out of order.

LCC 16/155 TO REVIEW FINANCIAL STATEMENT 2015/16

Prior to the meeting the clerk had circulated copies of the Annual Return 2016 together with the Receipt and Payment 2015/16 Schedule to members.

To date the clerk is unable to produce the audit timetable because no external audit correspondence has been received, and no Annual Return pack has arrived, upon making enquiries it is understood that BDO UK are no longer provider of audit services for community councils. The clerk believes that Grant Thornton has been appointed by the Welsh Audit Office as external auditors, but no documentation or correspondence has been received.

There were no issues arising from the Receipt and Payment 2015/16 Schedule. Councillor Mrs I. M. Tobias Quick proposed, Councillor H. Bryer seconded and all agreed that the accounts as prepared for 2015/16 be accepted and signed by the Chairman.

The accounts will be forwarded to the internal auditor (Mr Lyn Llewelyn) for his observations and approval in due course.

LCC 16/156 MAINTENANCE COSTS ASSOCIATED WITH STREET LIGHTING

The recent maintenance and energy charges associated with street lighting in the community of Llanarthne were discussed between Mrs Elaine Hanking, CCC and the clerk.

Seventy two community councils currently remain and get their maintenance and energy for street lighting with Carmarthenshire County Council. If we as a community council choose to remove the maintenance element from the Authority and be directly responsible for this maintenance work, then we will also need to find a new energy provider as well.

The Authority provides insurance cover and would pursue a third party claim on our behalf should a pole and lantern be accidentally damaged, a typical cost for a new pole and lantern is currently £2,500

All existing damaged lamps are replaced by the Authority using the latest lightemitting diode (LED) fittings which are more efficient, durable, and versatile and longer lasting.

Our existing incandescent street light could be made dimmable at a cost of circa £15.00 per lamp, the clerk will investigate matters further to establish if the money invested in dimmable lamps offers an energy saving in the long term, the typical life span of the existing lamps will also need to be considered if we were to proceed with dimmable lamps.

LCC 16/157 COMPLETED SCHOOL ROAD JUNCTION ONTO THE B4300

The community council is pleased to note that the recent road junction improvements undertaken at the School Road onto the B4300 has been satisfactory completed, and that visibility issues at this junction is much improved.

The clerk will write to Mr John McEvoy at the Highway Authority to express our appreciation to have this long awaited highway improvement undertaken at the said junction.

LCC 16/158 SPEEDING ISSUES

Clerk agreed to contact Mr Mike Jacob of the Highway Authority to establish if he is agreeable to attend the next meeting of the community council to agree an action plan to try and resolve speeding issues through the village of Llanarthne.

LCC 16/159 TENNIS COURT

In a recent letter to the community council the Hall Committee will not accept direct responsibility for the management and upkeep of the proposed multi use play area at the Margaret Bowen playing field if installed; furthermore they question the need for a proposed tennis court at this location when a tennis court already exists at Capel Dewi.

The clerk agreed to visit and inspect the tennis court at Capel Dewi and report back to the community council at the next meeting.

LCC 16/160 CLERK'S ADMINISTRATION MATTERS & SALARIES REVIEW

The following was agreed:

- Council members to have the meeting agenda and minutes in paper format as opposed to electronic copies.
- Due to the high number of emails received by the clerk pertaining to community council matters, the clerk to forward copies of emails which are of significance to members on a once weekly basis.
- Paper copies of planning application drawings to be made available as before by the clerk when discussing planning matters at council meetings.

Salaries

The rates for the National Living Wage and the National Minimum Wage from 1 April 2016 are ± 7.20 (per hour).

Councillor P. Edwards proposed, Councillor Mrs D. M. Jones seconded and all agreed that the hourly rates for Mr G. G. Griffiths and Mr T. R. Carruthers be increased from ± 6.50 to ± 7.50 which is above the National Minimum Wage

The clerks last pay review was undertaken in April 2003 when the clerks salary was increased from SCP 19 to SCP 21 (currently 10.261 / per hour) for a 5 hour week. Councillor H. Bryer proposed, Councillor Mrs I. M. Tobias Quick seconded and all agreed that the clerk's salary be increased from SCP 21 to SCP 27 (currently £12.317 / hour) with the hours worked increased from 5 hours to 7.5 hours per week. Clerk thanked members for their consideration.
