#### LCC 17/152 AREA MATTERS

CSO Jonathan Crayford, Dyfed-Powys Police gave members an update on community policing and local crime statistics, the agricultural community is currently the focus of many livestock and implement theft, metal theft locally is also on the increase, and a discussion ensued on speeding matters in and around our community.

The officer agreed that he will attend our meeting on a more regular basis. The chairman thanked him for attending our meeting.

### LCC 17/153 MEMBERS REPORTS

Clerk had attended the Steering Group Meeting of the Regency Restoration Project at the National Botanic Garden of Wales on the 24<sup>th</sup> March 2017. He advised members that the National Botanic Garden of Wales is celebrating a lottery award that will kick-start the biggest development in its history.

A grant from the Heritage Lottery Fund announced 1<sup>st</sup> March 2017 is the final piece of the jigsaw signalling the launch of the construction phase of a £7.2 million project to restore the legendary landscape of one of the finest Regency waterparks in Britain. The NBGW is currently working towards signing off their *Permission to Start* with Heritage Lottery Fund.

They are also planning the next Steering Group meetings, and have set the next one as 25<sup>th</sup> May 2017.

Clerk attended a Planning Seminar organised by the Local Authority on Friday 31<sup>st</sup> March 2017 at the Beacon Centre for Enterprise, Dafen, Llanelli. Since attending that meeting the following has been confirmed:

The adoption of the Carmarthenshire LDP in December 2014, the Council as the local planning authority has in effect by virtue of Policy H5 opposed the conversion of redundant rural buildings (such as barns) for the purposes of open market dwellings. The only form of residential conversion they advised they would support were those for affordable or local needs dwellings. In recognising the effects of the policy, since its adoption. Planning agents have been constantly lobbying the Authority's Forward Planning Manager and Head of Planning to reconsider its position with regard to open market conversions. Through the provision of a range of evidence, they have now accepted that the policy has had a catastrophic impact on the local economy and people, and as a result they will now accept planning applications once again for the conversion of redundant rural buildings of a traditional form for the purposes of residential dwellings.

Chair attended the Carmarthenshire Area Committee meeting held on Wednesday 5<sup>th</sup> April 2017 at St Peter's Civic Hall, Carmarthen, and gave members a brief account on the presentation made by the Dyfed-Powys Police and Crime Commissioner.

There were no other reports from members who had attended meetings as representatives of the council.

If the Community Council fails to fill the vacancies, then the Authority can exercise their power after Monday 12 June 2017, to order a fresh election to fill any remaining vacancies.

With respect to County Council Elections on the 4<sup>th</sup> May 2017. Mrs Ann Davies – Plaid Cymru, Bremenda Uchaf, Llanarthne, was unopposed and will take up office following the County Council Elections.
