LCC 17/122 PRELIMINARY MATTERS

a. Apologies

 Minutes of the Meeting of the Council held on Tuesday 10th January 2017 (Min. No's 107 – 121).

c. Matters arising from the above mentioned Minutes

[Min No 101 & 107(c)] Residents affected by inconsiderate parking along the School Road in Llanarthne have received a copy of the response from Mr Andrew J. Morgan, Traffic Engineer, Carmarthenshire County Council, and have been notified about the next community council meeting should they wish to attend, and discuss matters further.

[Min No 108(ii)] Clerk confirmed having purchased and installed polite notices pertaining to dog-fouling in and around the village of Llanarthne.

[Min No 108(v)] Clerk has inspected the recent road sweeping at Capel Dewi, and has requested another sweep following a rain shower.

[Min No 108(vi)] The three potholes itemised at the last council were filled on 24th January 2017. Keith the highway inspector has carried out an inspection of the junction near Beili-glas leading to Paxton tower from the B4300 and the carriageway was found to be in an acceptable standard, they will consider this section of carriageway for surface dressing treatment next financial year. Clerk was of the opinion that the wrong section of road had been inspected in this instance.

Pending Local Issues.

The following has been confirmed by Mr Tim Hammett, Carmarthenshire County Council.

- The pot holes around the inspection cover outside No 6 Tir Llan have been filled.
- The roundabouts outside the NBGW is in the programme for resurfacing, however surfacing sections are done on a priority basis when finances and resources are available, they are unable at present to give a definite date as to when the work will be undertaken.
- Where cycle route 47 runs on a publically maintained highway the same inspection regime is applied to the section of carriageway as would be applied to all carriageway with the same class hierarchy.
- Over hanging trees at Pont-Felin-gat to Dolau-Gwynon affecting overhead cables are not something which is dealt with by the council, if the trees were not in compliance with the highway act they have a procedure in place to serve notices on the land owners to cut back the trees, but this is not the case in this instance.
- It is our understanding the electric board has been undertaking work to cut back the trees on the B4300. We will also undertake an inspection of the carriageway and serve a notice on land owners for any trees that do not comply with the highway act.
- The Authority have carried out work to clean the cycle path by the Botanical Gardens, a sweeper attended site before Christmas.
- There are two designs proposed for the pavement adjacent the Wrights Food Emporium. One design incorporates a pavement only whilst the other includes a layby for parking bay provision. Discussions are ongoing with respect to the final proposal.
- They are unsure who is responsible for the maintenance of the seat opposite Llwyn Ddewi Capel Dewi but believe it may come under the community council.
- Request for litter bins at Pont Ffinnant Picnic site should be directed in the first instance to Mr Alan Warner, Countryside Operations Manager, Mynydd Mawr Woodland Park, Heol Hirwaun Olau, Tumble, SA14 6HU. Clerk confirmed having written to Mr Alan Warner.
- Request for litter bins by the bus shelter at Penyffin, Llanarthne should be directed in the first instance to: Marc I Davies, Environmental Controller, Cillefwr Depot, Alltycnap Road, Johnstown, Carmarthen. Clerk confirmed that he has written to Mr Marc Davies

- iii) Attendance Allowance and Financial Loss Allowance to each of their members where such loss has actually occurred, for attending approved duties outside the area of the council.

It was agreed to consider this matter at the next community council meeting.

LCC 17/131 TOWN & COMMUNITY COUNCIL/COUNTY COUNCIL ELECTIONS 2017

LCC 17/133 MAINS DRAINAGE

The provision for mains drainage sewerage system in Llanarthne, were put forward some forty five years ago. The current Bio digester Septic Tank installed near Hafandeg continues to produce an unacceptable pungent smell, it is also quite evident that this tank has to be emptied quite frequently and is undersized/specified to accommodate the intake volume. The former school site has planning approval for ten residential dwellings which would benefit from the provision of foul water mains drainage, including future development opportunities on land in the village identified as forming part of permitted development within the Local Development Plan. Existing residential and business properties in and around the village would also benefit by converting from private septic tanks to mains drains, since some private soakaways are proving to be problematic due to poor and unsuitable ground percolation conditions resulting from an above average high geological water table level.

Clerk agreed to contact Welsh Water on this matter.

LCC 17/134 PARKING ALONG THE SCHOOL ROAD, LLANARTHNE

Mr Andrew J. Morgan, Traffic Engineer, Carmarthenshire County Council has confirmed that the Authority will not support a residents parking scheme to be introduced along School Road in Llanarthne.

Residents were reminded that they can if they so wish place signs on their properties inhibiting car-parking outside their properties.

It was concluded that once the former Llanarthne School site is developed parking along this stretch of road will be greatly repressed, and should resolve the problem. In the meantime parking by the Church would be a better and preferred option as opposed to parking along the School Road, therefore any white line road marking discouraging parking at the Church location will need to be removed, and customers at the Wrights Food Emporium will need to be advised (by Mr Simon Wright) to park at this location, and not along the School Road.

Clerk agreed to contact the Authority on this matter.

LCC 17/135 SPEEDING ISSUES

Mr Mike Jocob, Road Safety Engineer, CCC recently advised that he has forwarded our recent request for greater police presence on speeding issues in Llanarthne to GoSafe but no update as promised has been received.

The village was discussed at a recent SMG (Speed Management Group Meeting). GoSafe (Safety Camera Partnership) they have officially adopted the village as a Community Concern site and have as such commenced enforcement. Regrettably enforcement as was promised has not continued on a regular basis, therefore we can assume that no results can be discussed or presented at the next Speed Management in April 2017.

In addition to the above they also agreed to monitoring traffic speeds before the next SMG to ascertain the impacts of the enforcement, but no such activity has taken place.

Our request to have speed limits from Capel Dewi to Llanarthne along the B4300 have also been ignored, including our request to have speed warning signs cleaned.

Councillor K. Thomas agreed to write formally to the Authorities Chief Executive and lodge a formal complaint.
