c. Matters arising from the above mentioned Minutes

[Min No 93(i)]. Clerk has been advised by the Highway Authority that various trees along the B4300 on land referred to as "Coed Mawr" from Ffinnant Bridge to the Old Oaks will be investigated. Also the "Armco" crash barrier recently damaged by a fallen tree on this stretch of road will also be investigated.

[Min No 93 (ii)]. Street lamp outside Erw Hir in Llanarthne is now in working order.

[Min No 93(iii)]. Clerk has received confirmation from the Authority that dislodged masonry stonework at Llanarthne Bridge will be investigated.

[Min No 98]. Maintenance work as specified on the recent tender schedule has commenced on the Penyffin and Llanarthne bus shelters.

[Min No 99]. Capel Dewi Community Association acknowledges and thanks our community council for the recent financial assistance given towards the Capel Dewi Eisteddfod in 2016.

- iii). Surface water road culvert blocked near Troed-y-rhiw-goch, Llanarthne.
- iv). Following the removal of a fallen tree near Gwynondale the hedgerow needs tidying up and make good road side including the removal of traffic cones.
- v). Repair work required to random rubble stonework at Pont ar Ffinnant bridge following a recent vehicular impact or collision of some sort.
- vi). Street lamp out of order at Pen-yr-heol, Cefn Abbey.
- vii). Street lights not always working on the slip road leading to the NBGW roundabout when leaving the M4. There is a lamp near the said roundabout that needs replacing or remove completely the remaining lamp base.

Issues to be brought to the attention of the Development Officer include:

Observations from this community council were made in respect of W/17004, and have not been addressed – no provision for passing places evident.

This application refers to a VARIATION OF CONDITION 2, whereas in fact the proposal is for six dwellings in lieu of a single storey communal area,

Is the increased barn height subject to a new application (first floor accommodation generated) in which case it cannot be considered as a variation?

The plans as submitted do not show what currently exists and what is proposed, - where is the biomass boiler and fuel stored?

No proposed pv panel array shown on the roof etc.

Photovoltaic panels on any roof surely warrants a new planning application and not a variation of condition.

No traffic management plan included identifying passing places on the public highway.

Should all six units proposed be subjected to a new planning application which includes the affordable housing levy?

The Head of Financial Services CCC informs that the Tax Base 2016/17 is 376.02 an increase of around 0.69% compared with last year, which was 373.45 The estimated costs of elections 2015/2016 is **£nil**. The precept for 2015/16 was £15,121.70 (Band D paid £40.49).
