## LCC 18/131 REMEMBRANCE STATUE

The clerk has undertaken the following;

- Researched the names of the deceased that are eligible for display within the war memorial statue.
- Contacted Mr Eirwyn Bennett regarding the names of the deceased, who then provided a source of information that displays all required records for WW1.
- Contacted the Vicar of Gorslas Church with regards to the deceased during WW2.
   Councillor Terry Davies provided guidance on record keeping. This guidance was provided as Gorslas and Llanarthne were part of the same Parish.
- Discussed possible quotations with Nia Bishop Memorials, Gorslas. Nia Bishop Memorials displayed a keen interest in supporting the project.
- Contacted Mr Gabrielle Hummerstone (Stone Mason), Golden Grove, who was recommended by Mr D T Davies (War Veteran) to undertake this work, as he has already undertaken a similar project at Llangathen Church. Unfortunately, Mr Hummerstone is currently unavailable, as he is hospitalised.

Chairperson (Councillor Mrs D M Jones) and County Councillor C A Davies have also made a significant contribution to this project, County Councillor C A Davies has obtained funding of £1000.00 towards the cost of the project.

It was agreed to proceed with this project and obtain three quotations for a war memorial, and to liaise with the Vicar of Llanarthne Parish Church, and the War Commissions.

## LCC18/132 KIOSK AT CAPEL DEWI

Llanarthne Community Council has agreed to discontinue the telephone service at the Capel Dewi location, in order to allow the adoption of a modern phone box with the installation of a defibrillator.

Carmarthenshire County Council agrees with this decision, and formally approves that the telephone box being used as a defibrillator station.

A cheque for the sum of £1 was paid to BT, in order to adopt the kiosk and it's telephone number; 01267290208.
